TELEFONICA EXPANDS SERVICE DELIVERY ACROSS PERU WITH SES AMERICOM-NEW SKIES

NSS-10 satellite enables Peru's largest telecom provider to serve remote locations

WASHINGTON, D.C. – June 2, 2009 – Delivering on the regional and global ambitions of its business, SES AMERICOM-NEW SKIES, a division of SES S.A. (Euronext Paris and Luxembourg Stock Exchange: SESG), today announced at the ITW conference in Washington, D.C. that Telefonica del Peru has signed a three-year deal for nearly a full transponder of satellite capacity to extend its reach to corporate, cellular and residential customers in remote areas of Peru.

Telefonica del Peru is using 33 megahertz of capacity aboard the NSS-10 satellite to deliver corporate voice and data solutions as well as broadband and mobile phone services to businesses and consumers in Peruvian towns and communities, many that are virtually inaccessible via terrestrial networks. The use of GSM backhaul over satellite is also enabling Telefonica del Peru to extend the capabilities of its metropolitan networks to remote locations, effectively eliminating the geographical barriers and prohibitive costs of the past.

“Using the reach of SES AMERICOM-NEW SKIES’ reliable NSS-10 satellite, Telefonica del Peru is offering seamless corporate, cellular and residential communications services between major cities like Lima and Puerto Maldonado in Peru,” said Carlos Flores Ganoza, Network Planning Manager for Telefonica del Peru. “Increasingly, satellite-delivered voice and data, GSM backhaul, broadband and mobile phone services are opening the door to newfound communications capabilities and business opportunities in rural mining and farming villages that were once out of touch. We have turned to the leading satellite and operator in the region to help us make the most of this exciting evolution for our business and our customers.”
