Settlement Amount I – Each "Cap" Certificate shall entitle the Certificateholder to receive one of the following Settlement Amounts, as the case may be, on the Settlement Date :

(i) Maximum Redemption if $VALUE_t$ is greater than or equal to the Upper Limit

(ii) 1 EUR x ($VALUE_t$ - Lower Limit) if $VALUE_t$ is strictly comprised between the Lower Limit and the Upper Limit

(iii) 0 EUR if $VALUE_t$ is less than or equal to the Lower Limit

II – Each "Floor" Certificate shall entitle the Certificateholder to receive one of the following Settlement Amounts, as the case may be, on the Settlement Date :

(i) Maximum Redemption if $VALUE_t$ is less than or equal to the Lower Limit

(ii) 1 EUR x ($VALUE_t$ – Upper Limit) if $VALUE_t$ is strictly comprised between the Lower Limit and the Upper Limit

(iii) 0 EUR if $VALUE_t$ is greater than or equal to the Upper Limit

where :

$VALUE_t$ means the closing price of the Index on the Final Valuation Date, subject to the provisions of the definition of Final Valuation Date below.

Final Valuation Date

Each of the dates specified in the table above. However, if such date is not a Trading Day, the Final Valuation Date shall be the first Trading Day of the Valuation Period, provided that if there is no Trading Day within the Valuation Period, the last day of the Valuation Period shall be deemed to be the Final Valuation Date and $VALUE_t$ shall be deemed to be the Fair Market Value.

Fair Market Value	The value of the Index determined by the Calculation Agent after consultation with an independent expert designated by Société Générale, on the basis of the market conditions on the last day of the Valuation Period.
Maximum Redemption	200 EUR.
Settlement Date	The Maturity Date.
Valuation Period	The period of 5 (five) calendar days which follows the Final Valuation Date.
